Inulin (chicory), activated carbon (coconut shell), papaya fruit powder (*Carica papaya* L.), 4.8 % pineapple fruit juice powder (*Ananas comosus* L.), flavouring, acid: citric acid, thickener: guar gum, nettle leaf extract 10:1 (*Urtica dioica*, contains 2 % silicon dioxide), 1.6 % coconut flakes (*Cocos nucifera* L.), 1.6 % coconut milk powder (coconut milk, glucose syrup), black radish rootstock powder (*Raphanus sativus*), Chinese hawthorn berry powder (*Crataegus pinnatifida*), dandelion root powder (*Taraxacum officinale*), acerola fruit juice powder (*Malpighia glabra*, contains 17 % vitamin C), natural flavouring, black garlic extract 10:1 (*Allium sativum* L.), grape seed extract 27:1 (*Vitis vinifera* L., contains 50 % oligomeric proanthocyanidins), Indian psyllium seed husk powder (*Plantago ovata*), ginger rootstock powder (*Zingiber officinale* L.), green tea extract (*Camellia sinensis* L., contains 55 % epigallocatechin gallate), sweetener: sucralose, black pepper fruit extract (*Piper nigrum*, contains 95 % piperine)
